Project News

East Wick and Sweetwater - Joint Venture at Queen Elizabeth Olympic Park

This joint venture, in which LBC are providing the Building Control on, is developing the two new East Wick and Sweetwater neighbourhoods of 1,800 homes to Queen Elizabeth Olympic Park as well as new schools, nurseries, commercial and community spaces.

The initial phase, which marks the first of seven construction phases, will see the delivery of four mixeduse buildings, including 302 apartments, townhouses and several associated commercial facilities including retail and leisure amenities.

Work is well underway with completion expected in Summer 2021. At construction peak, the project will employ approximately 500 people with 7% of its workforce formed of apprentices. A selection of homes has already been released for sale, following on from a successful start letting the first apartments with new residents moving in soon.

Latest Updates Building Safety Bill



The draft Building Safety Bill was issued in response to the Grenfell Tower disaster and subsequent building regulation reviews. It proposes a radical new approach to the regulatory system for building control and building safety in England. The draft bill defines certain buildings in scope as 'higher risk buildings' which warrant additional oversight from a regulatory perspective. Although still yet to be confirmed, buildings where people live and sleep such as apartment blocks, supported accommodation and student residences over 18m tall are likely to be covered by the new regime. It proposes new committees as well as a new Homes Ombudsman to action the necessary reform.

Based on Hackitt report proposals, the Building Safety Regulator (BSR) will head up the new building safety regime with key aims that include the implementation of a more stringent national safety system for in-scope buildings and enforce strict sanctions for those who do not comply. It will also lead on measures to improve the competence and scrutinise professionals working in the built environment sector. It will also have involvement in the Building Control function on in scope buildings with increased regulation and probity of Building Control Bodies approved to work on such schemes.

Another key feature of the Bill, championed by Robert Jenrick MP the secretary of State for Housing, is that it will focus on a 'new era of accountability'. A new gateway system for 'duty holders' is proposed with the objective of allocating responsibility to different phases of the building's lifecycle. During the design and construction phase, principle designers and contractors with be primarily accountable with the BSR assessing, controlling and authorising the building safety process. A 'golden thread' of information will be a major part of the new procedure connecting the different phases and will be readily accessed at any point. The building will only be certified once the BSR is satisfied that the accountable person has met all statutory obligations and will also be required to appoint a Building Safety Manager to support the day-to-day management of the building.

There is still a lot more details to flesh out before this Bill becomes legislation, but LBC supports the principles of the Building Safety Bill for the betterment of building safety and has already taken steps to implement upcoming changes.

Setting the Bar – A new competence regime for building a safer future

Over the last two years The Competence Steering Group (CSG) has bought together organisations across the built environment and fire industries organisations representing building owners and manager with the aim of producing a blueprint to improve competence for those working on higher-risk buildings and drive a culture of change right across the industry.

Setting the Bar is the second and final report of the CSH and us an update of their previous report published in 2019. The work was initiated by the recommendations in Dame Judith Hackitt's review Building A Safer Future.

London Building Control welcome this final report and are committed to seeing the recommendations implemented.

Changes to Part B – Fire Safety New Sprinkler and Wayfinding guidance published.

The government has published amendments to Approved Document B of the Building Regulations Fire Safety Volume 1 Dwellings.

There are two main important changes:

- Blocks of flats with their top storey more than 11m above ground level should be fitted with a sprinkler system throughout the building.
- Wayfinding signage for the fire service should be provided in all blocks of flats with a top storey more than 11m above ground level. Floor identification signs should be provided on every landing of a protected stairway and every protected corridor/lobby into which a firefighting lift opens. Flat indicator signs to identify flat numbers should also be used and supplemented by arrows where necessary. Guidance is given on the location, font and size of signage.

The changes apply to new-build, changes of use, material alterations and extensions.

The changes in the amendment take effect on 26 November 2020 and MHCLG has announced the transitional provisions:

- Where an Initial Notice has been served before 26 November 2020 and the work has started before 29 January 2021, the 2019 Approved Document B will apply.
- Where an Initial Notice has been served after 26 November 2020 or the work has not started before 29 January 2021, the 2020 amendments will apply.

Key events at the start of 2020 included a series of physical networking runs and walks and when lockdown came the support of LBC allowed


